We incorporated Mathematics and Science days in recruiting strategy. We worked closely to monitor science candidates as a team of science professors, secondary education professors, and academic advisors. We encouraged candidates to engage in the greater school community and to assist with the middle and high school tutoring programs.

The coursework helps candidates learn to plan instruction using appropriate technologies and incorporate technologies to better understand data collection and analysis; and the strategies are annually evaluated.
