You will be certified for each term in which you are enrolled. If you do not wish to be certified at any time, you must notify the School Certifying Official immediately.

The VA Certifying Official can only certify to the VA enrollment in courses that are required for your Ottawa University degree/major as defined in your approved graduation plan and the Ottawa University catalog. Once an area of requirement is met, no other courses may be certified for that area unless there is unmet elective credit available.

The VA may not pay for repeated courses unless an improved grade is required for graduation. Audited courses cannot be certified to the VA.

If you change your degree or major, you may be asked to resubmit a new Compliance Agreement.

The VA requires educational institutions to report information as it relates to unsatisfactory progress. If you stop attending a class and do not officially withdraw from it, you will receive a failing grade. We are required to report this information to the VA. The VA will note the last date of attendance and will consider this a reduction in enrollment. They will charge an overpayment against your VA education benefits.

If you drop or add classes, or are dropped for nonpayment or nonattendance, your enrollment status may change and will be reported to the VA. These changes can result in an overpayment as determined by the VA.

An overpayment by the VA may create a balance due to the University. Please notify your certifying official IMMEDIATELY if you change credits in a given term by adding/dropping a course or if you withdrawl from all credits/courses in a specific semester or term in order to avoide a balance owed.
