Dear President Eichner,

The Baccalaureate/Graduate Degree Board of Commissioners met on April 15<sup>th</sup>, 2016 and approved the business program accreditation at Ottawa University. Congratulations! Conditions and notes indicate that either the Standard or Criteria is not fully met, and should be viewed as an opportunity to move your program to a higher level of excellence. It would be extremely rare that a school receive accreditation without these conditions or notes given ACBSP's Core Value of Continuous Improvement and Organizational Learning, that "Business schools and programs should pursue regular cycles of planning, execution, and evaluation of every process and system. Ongoing improvement of these processes and systems leads to ever higher quality and student/stakeholder satisfaction."

The accreditation decision included the following Notes provided by the Board of Commissioners:

**Place a Note on Standard 3, Criterion 3.2:** The business unit currently obtains feedback from stakeholders. However, the business unit has determined the need to establish a business advisory board for business and educational entities as well as an adjunct faculty council.

**Place a Note on Standard 4, Criterion 4.3:** The business unit has a systematic learning outcomes data process that is available and analyzed in its bachelors and masters programs. The business unit is in the process of reaching out to other universities to gather benchmarking data and they have recently adopted ETS Major Field Tests which will be first administered to students this year.

**Place a Note on Standard 5, Criterion 5.3.2.b:** The business unit does not currently meet the criteria of at least 40 (24) percent of the undergraduate credit hours in business and 70 (65) percent of graduate hours in business are taught by academically/professionally qualified faculty.

**Place a Note on Standard 5, Criterion 5.5**: The business unit is moving to 12 month contracts which requires faculty to teach 10 classes. There are currently some faculty members on nine month contracts, but five of the full-time faculty are teaching eight preps with overloads.

One-half of the administrators are teaching preps as well as being engaged in scholarly and professional activities.

**Place a Note on Standard 6, Criterion 6.1.7:** The business unit provides a timeline of assessment from 2013-2014 to 2023-2024 which includes student satisfaction, alumni, program completion, etc. Information provided included several means of evaluation for students and alumni. However, results are not reported for enrollment, attendance rates, dropout rates, complaints, etc.

Progress on the notes must be reported in future Quality Assurance Reports. You are encouraged to work with Dr. Charlene Connor on the removal of the notes and conditions. Your Quality Assurance Report will be due on February 15<sup>th</sup>, 2016 and every two years after that. Your ten year reaffirmation will be due on 2026.
